While we are not all gathered in person for our 127th Annual Meeting of the Episcopal Diocese of Los Angeles, we are well and truly together in spirit.



Seating, Attendance & Participation

The spirit of Diocesan Convention is that of a family reunion. In light of the pandemic, however, we must prioritize health and safety while ensuring accessibility and inclusivity as we come together to do the work of the diocese.

As such, Diocesan Convention 2022 is a hybrid event. Delegates have the choice to participate in person or by Zoom webinar. Masks are not required but are strongly recommended, especially for unvaccinated guests attending in person.

We also ask everyone to continue to respect the safety boundaries many have set for themselves, using fist bumps and waves as a substitute for closer physical contact. Many thanks to all who are vaccinated. Thank you for helping us take care of each other!

In-person participation:

- Registration opens at 1:00 p.m. on Friday and 8:00 a.m. on Saturday. Delegates must visit the Registration table to receive their credentials and printed materials. Delegates entitled to seat, voice, and vote also will be assigned a voting device for use during the business session.
- Alternates who need to change their status to delegate must check in with the Registrar and complete a status change form.

Virtual participation:

- Delegates choosing to participate virtually must register for the Zoom webinar in advance by following the link posted on the convention website at <u>www.diocesela.org/convention</u>.
- Alternates who need to change their status to delegate must contact the Registrar on the morning of convention. The link for this separate Zoom meeting will be posted at the very top of the convention website at <u>www.diocesela.org/convention</u>.
- Spanish language translation will be provided. There is no default language so every delegate will need to click on the "interpretation" icon at the bottom of the screen and select English or Spanish when they log in to the webinar.
- All voting will be done electronically. Some may feel comfortable switching between windows on their device, but it is <u>recommended that voting delegates use two devices</u> <u>during convention</u>; for example, a computer and a smartphone.
 - 1. On one device, or in one window, join the Zoom webinar by clicking the link in your email.
 - 2. On a second device, or in a second window, use a web browser to visit <u>ttpoll.com</u> and enter the Session ID that was emailed with your materials.

Ballots will be presented on Zoom but virtual delegates cast their votes on <u>ttpoll.com</u> by pressing the number corresponding to their answer. If the number highlights blue, the vote has been registered. Delegates can change their answer as long as the vote is open by pressing a new option. The last button pressed is the vote registered.



Resolutions Referred from the 80th General Convention

Per Canon I.1.1.e of the Constitution and Canons of the Episcopal Church, whenever any alteration of the Book of Common Prayer or of the Constitution is proposed, dioceses must make these proposed changes known at their annual Convention.

The 80th General Convention proposed three resolutions with changes to the Constitution. The changes shall be read aloud at Diocesan Convention and the text in its entirety is printed below.

The Secretary of Convention

A031 Amend the Constitution and Canons Relating to Mergers of Dioceses

Resolved, **That the 80th General Convention amend Article V, Section 4 of the Constitution to read as follows:**

<Amended text as it would appear if adopted and concurred. Scroll below the line of asterisks (******) to see the version showing all deleted and added text.>

Art.V

Sec. 4. Whenever a new Diocese is formed and erected out of an existing Diocese or out of two or more existing Dioceses or parts of them, the formation process of the newly formed Diocese, including the adoption of its Constitution and Canons, shall be as set forth in the Canons.

<Proposed amended resolution text showing exact changes being made:>

Resolved, **That the 80th General Convention amend Article V, Section 4 of the Constitution to read as follows:**

Art.V

Sec. 4. Whenever a new Diocese is formed and erected out of an existing Diocese *or out of two or more existing Dioceses or parts of them*, it shall be subject to the Constitution and Canons of the Diocese out of which it was formed, except as local circumstances may prevent, until the same be altered in accordance with such Constitution and Canons by the Convention of the new Diocese the formation process of the newly formed Diocese, including the adoption of its Constitution and Canons, shall be as set forth in the Canons.

Whenever a Diocese is formed out of two or more existing Dioceses, it shall be subject to the Constitution and Canons of that one of the said existing Dioceses to which the greater number of Members of the Clergy shall have belonged prior to the erection of such new Diocese, except as local circumstances may prevent, until the same be altered in accordance with such Constitution and Canons by the Convention of the new Diocese.

And be it further

Resolved, That Canon I.10 be amended to read as follows and voted on at the 81st General Convention:

<Amended text as it would appear if adopted and concurred. Scroll below the line of asterisks (******) to see the version showing all deleted and added text.>

Can.I.10

Sec. 1. Whenever a new Diocese is proposed to be formed within the limits of any Diocese, or by the junction of two or more Dioceses, or parts of two or more Dioceses, the Ecclesiastical Authorities and the Standing Committees of the Dioceses involved in the proposed new diocese shall submit for approval to the Conventions of each Diocese involved a joint agreement of union setting forth their agreements, including the manner of determining the Bishop Diocesan and other Bishops (if any), the provisions of the Constitution and Canons of the new Diocese, and such other matters as may be necessary or proper. Upon approval by the Conventions of each of the involved Dioceses, the joint agreement of union shall be submitted for ratification by the General Convention no less than ninety days prior to the first legislative day of the next meeting of the General Convention.

Sec. 2. Promptly after ratification by the General Convention, the Ecclesiastical Authority of the new Diocese, as set forth in the joint agreement of union, shall call the first Convention of the new Diocese, for the purpose of enabling it to organize, and shall fix the time and place of holding the same, such place being within the territorial limits of the new Diocese.

Sec. 3. Whenever one Diocese is about to be divided into two Dioceses, the Convention of such Diocese shall declare which portion or portions thereof are to be in the new Diocese, and shall make the same known to the General Convention before the ratification of such division.

Sec. 4. Whenever a new Diocese shall have organized in first Convention in accordance with the provisions of the Constitution and Canons in such case made and provided, and in the manner prescribed in the previous Sections of this Canon, and shall have chosen a name and acceded to the Constitution of the General Convention in accordance with Article V, Section 1 of the Constitution, and shall have laid before the Executive Council certified copies of the Constitution adopted at its first Convention, and the proceedings preparatory to the formation of the proposed new Diocese, such new Diocese shall thereupon be admitted into union with the General Convention.

Sec. 5. In the event of the erection of an Area Mission into a Diocese of this Church, as provided in Article V, Section 1 of the Constitution, the Convocation of the Area Mission shall be entitled to elect Deputies to the succeeding General Convention, and also to elect a Bishop. The jurisdiction previously assigned to the Bishop in the Area Mission shall be terminated upon the admission of the new Diocese.

Sec. 6. When a Diocese and one or more other Dioceses that were formed either by division therefrom or by erection into a Diocese or a Missionary Diocese formed by division therefrom, shall desire to be reunited into one Diocese, the proposed reunion must be initiated by the approval of the Conventions of the involved Dioceses of a joint agreement of union setting forth their agreements, including the manner of determining the Bishop Diocesan and other Bishops (if any), provisions of the Constitution and Canons of the new Diocese, and such other matters as may be necessary or proper. If the agreement of the Dioceses is made and the consents of their Conventions are given more than three months before the next meeting of the General Convention, the fact of the agreement and consents shall be certified by the Ecclesiastical Authority and the Secretary of the Convention of each involved Diocese to all the Bishops of the Church having jurisdiction and to the Standing Committees of all the Dioceses; and when the consents of a majority of such Bishops and of a majority of the Standing Committees to the proposed reunion shall have been received, the facts shall be similarly certified to the Secretary of the House of Deputies of the General Convention, and thereupon the reunion shall be considered complete. But if the agreement is made and the consents given within three months of the next meeting of the General Convention, the facts shall be certified instead to the Secretary of the House of Deputies, who shall lay them before the two Houses; and the reunion shall be deemed to be complete when it shall have been approved by a majority vote in the House of Bishops, and in the House of Deputies.

Sec. 7. When the union of two or more Dioceses or portions of Dioceses or the reunion of the two or more Dioceses shall have been completed, the facts shall be certified to the Presiding Bishop and to the Secretary of the House of Deputies. Thereupon the Presiding Bishop shall notify the Secretary of the House of Bishops of any alteration in the status or style of the Bishop or Bishops concerned, and the Secretary of the House of Deputies shall strike the name of any Diocese that will cease to exist or is being renamed from the roll of Dioceses in union with the General Convention and, if appropriate, amend the name of the newly united Diocese on the roll of Dioceses in union with the General Convention.

<Proposed amended resolution text showing exact changes being made:>

Can.I.10

Sec. 1. Whenever a new Diocese is proposed to be formed within the limits of any Diocese, or by the junction of two or more Dioceses, or parts of *two or more* Dioceses, the Ecclesiastical Authorities and the Standing Committees of the Dioceses involved in the proposed new diocese shall submit for approval to the Conventions of each Diocese involved a joint agreement of union setting forth their agreements, including the manner of determining the Bishop Diocesan and other Bishops (if any), the provisions of the Constitution and Canons of the new Diocese, and such other matters as may be necessary or proper. Upon approval by the Conventions of each of the involved Dioceses, the joint agreement of union shall be submitted for ratification by the General Convention no less than ninety days prior to the first legislative day of the next meeting of the General Convention.

Sec. 2. Promptly after ratification by the General Convention, the Ecclesiastical Authority of the new Diocese, as set forth in the joint agreement of union, shall call the Primary *first* Convention of the new Diocese, for the purpose of enabling it to organize, and shall fix the time and place of holding the same, such place being within the territorial limits of the new Diocese.

Sec. 3. Whenever one Diocese is about to be divided into two Dioceses, the Convention of such Diocese shall declare which portion *or portions* thereof *are* is to be in the new Diocese, and shall make the same known to the General Convention before the ratification of such division.

Sec. 4. Whenever a new Diocese shall have organized in *first* Primary-Convention in accordance with the provisions of the Constitution and Canons in such case made and provided, and in the manner prescribed in the previous Sections of this Canon, and shall have chosen a name and acceded to the Constitution of the General Convention in accordance with Article V, Section 1 of the Constitution, and shall have laid before the Executive Council certified copies of the Constitution adopted at its *first* Primary Convention, and the proceedings preparatory to the formation of the proposed new Diocese, such new Diocese shall thereupon be admitted into union with the General Convention.

Sec. 5. In the event of the erection of an Area Mission into a Diocese of this Church, as provided in Article V, Section 1 *of the Constitution*, the Convocation of the Area Mission shall be entitled to elect Deputies to the succeeding General Convention, and also to elect a Bishop. The jurisdiction previously assigned to the Bishop in the Area Mission shall be terminated upon the admission of the new Diocese.

Sec. 6. When a Diocese and one or more other Dioceses that were formed either by division therefrom or by erection into a Diocese or a Missionary Diocese formed by division therefrom, shall desire to be reunited into one Diocese, the proposed reunion must be initiated by the approval of the Conventions of the involved Dioceses of a joint agreement of union setting forth their agreements, including the manner of determining the Bishop Diocesan and other Bishops (if any), provisions of the Constitution and Canons of the new Diocese, and such other matters as may be necessary or proper. If the agreement of the Dioceses is made and the consents of their Conventions are given more than three months before the next meeting of the General Convention, the fact of the agreement and consents shall be certified by the Ecclesiastical Authority and the Secretary of the Convention of each involved Diocese to all the Bishops of the Church having jurisdiction and to the Standing Committees of all the Dioceses; and when the consents of a majority of such Bishops and of a majority of the Standing Committees to the proposed reunion shall have been received, the facts shall be similarly certified to the Secretary of the House of Deputies of the General Convention, and thereupon the reunion shall be considered complete. But if the agreement is made and the consents given within three months of the next meeting of the General Convention, the facts shall be certified instead to the Secretary of the House of Deputies, who shall lay them before the two Houses; and the reunion shall be deemed to be complete when it shall have been approved by a majority vote in the House of Bishops, and in the House of Deputies.

Sec. 7. When the union of two or more Dioceses or portions of Dioceses or the reunion of the two or more Dioceses shall have been completed, the facts shall be certified to the Presiding Bishop and to the Secretary of the House of Deputies. Thereupon the Presiding Bishop shall notify the Secretary of the House of Bishops of any alteration in the status or style of the Bishop or Bishops concerned, and the Secretary of the House of Deputies shall strike the name of any Diocese that will cease to exist or is being renamed from the roll of Dioceses in union with the General Convention and, if appropriate, amend the name of the newly united Diocese on the roll of Dioceses in union with the General Convention.

A059 Amend Article X of the Constitution of The Episcopal Church (First Reading)

Resolved, That the 80th General Convention of The Episcopal Church repeal Article X in its entirety and replace it with the following:

Sec. 1. The Book of Common Prayer is understood to be those liturgical forms and other texts authorized by the General Convention in accordance with this article and the Canons of this Church.

The Book of Common Prayer in this Church is intended to be communal and devotional prayer enriched by our church's cultural, geographical, and linguistic contexts. The Book of Common Prayer shall contain both public worship and private devotion.

The Book of Common Prayer, as now established or hereafter amended by the General Convention, shall be in use in all the Dioceses of this Church.

Sec. 2. No alteration thereof or addition thereto shall be made unless the General Convention approve the same on first reading in one regular meeting of the General Convention and, by resolve so directing, be sent by the Secretary of the General Convention to the Secretary of the Convention of every Diocese, to be made known to the Diocesan Convention at its next regular meeting, and be adopted on second reading without alteration by the General Convention at its next succeeding regular meeting by a majority of all Bishops, excluding retired Bishops not present, of the whole number of Bishops entitled to vote in the House of Bishops, and by an affirmative vote by orders in the House of Deputies in accordance with Art. I, Sec. 5 of this Constitution, except that concurrence in the affirmative by the orders shall require the affirmative vote in each order by a majority of the Dioceses entitled to representation in the House of Deputies.

Sec. 3. No alteration thereof or addition thereto shall be made unless it has previously been authorized for Trial Use in accordance with this Article and the Canons of this Church.

Sec. 4. The General Convention may at any one meeting, by a majority of the whole number of the Bishops entitled to vote in the House of Bishops, and by a majority of the Clerical and Lay Deputies of all the Dioceses entitled to representation in the House of Deputies, voting by orders as previously set forth in this Article:

a. Amend the Table of Lessons and all Tables and Rubrics relating to the Psalms.

b. Authorize for Trial Use such alterations or additions in whole or in part to the established Book of Common Prayer as may be proposed in accord with the Canons of this Church and duly undertaken by and implemented according to the

directives of the General Convention.

c. Authorize for use throughout this Church, as provided by Canon, alternative and additional liturgies to supplement those provided in the Book of Common Prayer.

Sec. 5. Nothing in this Article shall be construed as restricting the authority of the Bishops of this Church to take such order as may be permitted by the Rubrics of the Book of Common Prayer or by the Canons of the General Convention for the use of special forms of worship.

And be it further

Resolved, That the General Convention direct the President of the House of Deputies and the Presiding Bishop to appoint a working group of nine members to include the Custodian of The Book of Common Prayer, some members of Committee 12 of the 80th General Convention, some members of a Standing Commission on Liturgy and Music, and others as needed to review the Canons relevant to the implementation of this Article and propose revisions to the 81st General Convention. An initial framework is provided as a starting point for this work; and be it further

Resolved, That an allocation of \$30,000 be made to support the work of the working group.

The Committee is enjoined from including in its report any judgment on the merits of the substance of any resolutions' passage or defeat. However, the Committee may finalize the form of the resolutions, which has been done to the extent possible with the proponents of the resolutions.

A total of five resolutions were submitted to the Secretary of Convention in 2022. By majority vote, the Committee approved all five to move forward to Convention for consideration.

Proposed Resolution Regarding the Establishment of a Diocesan Compensation & Benefits Program Group

Resolved, that the One Hundred Twenty-seventh Annual Meeting of the Church in the Diocese of Los Angeles request a Diocesan Compensation & Benefits Program Group be appointed by the Bishop Diocesan with the approval of Diocesan Council with membership comprised of clergy and lay leaders of Episcopal congregations, institutions, and schools of the Diocese, who reflect the demographic and geographic diversity of the Diocese; and be it further

Resolved, that the Compensation & Benefits Program Group will meet regularly, and report annually to the Diocesan Convention describing work done since the last Convention, and work identified for the coming year.

Explanation:

After three years of conversation and study as a working group, it is clear that the resolutions presented to the 127th Annual Meeting of the Church in the Diocese of Los Angeles are only a beginning of necessary work concerning compensation and benefits of clergy and lay employees of Episcopal congregations, institutions, and schools. We need the steady presence of a Compensation & Benefits Program Group to maintain just standards of compensation & benefits for all employees, to work toward greater parity of compensation & benefits for lay and ordained employees, and to provide resources and education for institutions of the Diocese as they navigate the complex world of compensation & benefits.

Proposed Resolution Regarding Clergy Compensation Minimums

Resolved, that the One Hundred Twenty-seventh Annual Meeting of the Church in the Diocese of Los Angeles define the Total Clergy Compensation (TCC) as the total of cash stipend + utilities allowance + housing (valued at 30% of salary when housing is provided or a cash housing allowance that reflects actual housing costs & is authorized annually by the Vestry when housing is not provided) + SECA (Self Employment Contribution Act) reimbursement at 50% of cost + all other cash compensation paid to an individual clergyperson. TCC does not include benefits (e.g. pension, health or dental insurance) or reimbursements for job-related expenses such as mileage; and be it further

Resolved, that the minimum TCC for active parochial clergy, applicable to a full-time rector, vicar, priest-in-charge, interim, or chaplain who directs programs and sets policies, is set at \$70,000, plus \$4000 for every five years of prior service, up to a maximum of fifteen years; and be it further

Resolved, that the minimum TCC for full-time assisting clergy be no less than 2/3 of the TCC of the priest or chaplain in charge of the congregation or other ministry; and be it further

Resolved, that California COLA increases are to be included each year as part of the minimum salary increase; and be it further

Resolved, that in setting salary, employers consider, in addition to the minimum salary, appropriate compensation for years of applicable experience, languages spoken, size and complexity of the ministry, advanced training or degrees, and any other special circumstances; and be it further

Resolved, that part-time clergy serving in parishes and missions will have their number of working Sundays reflect compensation status: ³/₄ time equals 3 out of 4 Sundays working, or whatever schedule of working Sundays is suitable for both the congregation and the clergyperson, e.g., 12 Sundays off during the summer; and be it further

Resolved, that clergy working part-time for two institutions whose total working hours qualify them for benefits will have the cost of their benefits shared proportionally by the two institutions; and be it further

Resolved, that the minimum standard for health insurance benefits is full coverage for the employee in one of the two most reasonable plans offered in the diocese by the Medical Trust, with additional coverage provided at the employee's expense through pre-tax payroll deduction; and be it further

Resolved, that all clergy currently employed may retain their current level of benefits under their current Letter of Agreement or other contract or understanding until such time as they leave their current employer; and be it further

Resolved, that the Compensation & Benefits Program Group review these standards annually, and update them as appropriate with the approval of the Diocesan Convention.

Explanation:

The clergy salary minimum has not been updated by Convention since 2006, at which time it was set at \$60,000, plus \$3000 for every five years of prior service, beginning in 2009. California

COLA increases between 2009 and now would have raised that figure to \$80,196. The minimum salary in California for an exempt employee (except classroom teachers) is \$64,480 for 2023. The Compensation Working Group recognizes that this update of clergy compensation minimums is long overdue, and that the proposed resolution both fails to keep up with inflation and will present financial challenges for some congregations, institutions, and schools. Clearly, more work needs to be done developing resources to assist Episcopal institutions, especially those in search processes, to develop just clergy compensation & benefits packages appropriate to their particular settings.

Proposed Resolution Regarding Parity for Ordained and Lay Church Employees

Resolved, that the One Hundred Twenty-seventh Annual Meeting of the Church in the Diocese of Los Angeles reaffirms the action of the 111th Convention of the Episcopal Diocese of Los Angeles, which established the Living Wage as the minimum wage paid to all employees of institutions of the Diocese; and be it further

Resolved, that all Episcopal congregations, institutions, and schools familiarize themselves and comply with all State and Federal employment laws governing exempt and non-exempt employees; and be it further

Resolved, that the One Hundred Twenty-seventh Annual Meeting of the Church in the Diocese of Los Angeles affirms Resolution B026 of the 77th General Convention, which calls for participation in the Episcopal Church Medical Trust by December 31, 2012 and "parity in cost-sharing" of health insurance premiums for clergy and lay church employees by December 31, 2015; and be it further

Resolved, that employees working part-time for two Episcopal institutions whose total working hours qualify them for benefits will have the cost of their benefits shared proportionally by the two institutions; and be it further

Resolved, that all employees may retain their current level of benefits under their Letter of Agreement or other contract or understanding until such time as they leave their current employer; and be it further

Resolved, that all congregations, institutions, and schools examine parity of compensation & benefits for their lay and clergy employees, and work toward achieving parity; periodically, the Compensation & Benefits Program Group will ask Episcopal institutions to report on their plan for and progress toward parity.

Explanation:

Historically, lay employees of Episcopal institutions have suffered with lower rates of compensation and less generous benefits than clergy employees. While the journey to providing parity of compensation & benefits for clergy and lay employees may take time, this resolution reminds us of the commitments toward just compensation and parity already established by the Episcopal Diocese of Los Angeles and the Episcopal Church, and asks all Episcopal congregations, institutions, and schools to examine where they are achieving parity and where work remains to be done. For 2023, the minimum salary in California for an exempt employee (except classroom teachers) is \$64,480; fulltime employees making less than \$64,480 in 2023 are non-exempt and legally protected by compensation and employment practice regulations.

Proposed Resolution Regarding the Diocese of Los Angeles's Commitment to Engage with the Episcopal Church's Covenant for the Care of Creation

Resolved, that the One Hundred Twenty-seventh Annual Meeting of the Church in the Diocese of Los Angeles, adopts the principles outlined in the Episcopal Church's <u>Covenant for Care of Creation</u> – to grow our love for the Earth and all of life through preaching, teaching, storytelling and prayer; to stand alongside marginalized, vulnerable peoples, in order to advocate and act to repair Creation and seek the liberation and flourishing of all people; and to adopt practical ways of reducing our climate and other ecological impacts and living more humbly and gently on Earth as individuals, households, congregations, institutions, and as a diocese – as guidelines for diocesan action on matters of policy, administration, and governance concerning matters of creation care and climate change.

Explanation:

The Diocese of Los Angeles has committed itself repeatedly to environmental principles (See: Resolution regarding Environmental Stewardship and Climate Change, 2006; Resolution regarding the Sacredness of Water and Environmental Sustainability, 2011; Resolution regarding Divestment, 2014). So has the General Convention of the Episcopal Church (See: 2018-C008, Encourage Sustainable Choices to Combat Climate Change; 1991-A195, Affirm Environmental Responsibility and an Environmental Stewardship Team, as well as the resolutions from General Convention 2022 (GC80): A020, A087, and D064, and House of Bishops closing statement expressing "Mind of the House" on climate and our vocation in Christ). Other dioceses in California have already committed themselves to this Covenant (For example, see: Resolution 21-06, Diocese of San Diego, Putting into Practice Locally the Episcopal Covenant for the Care of Creation). By adopting the principles set out in the Covenant for Creation Care, the Diocese of Los Angeles will be equipped with a theological framework for individual and corporate action on matters of environmental stewardship and climate change.

Proposed Resolution Regarding the Adoption of Guidelines for the Environmental Reformation of the Diocese of Los Angeles

Resolved, that the One Hundred Twenty-seventh Annual Meeting of the Church in the Diocese of Los Angeles, in order to align the Diocese with the guidelines presented in the churchwide "Episcopal Covenant to Care of Creation - Putting it into Practice," and General Convention 2022 (GC80) Resolutions A020, A087, and D064, encourage the Bishop and Diocesan Council to identify and implement practical, cost-effective measures to address climate change in the day-to-day operation of the diocese; and be it further

Resolved, that Diocesan Council identify in detail, during fiscal year 2023, the costs and requirements to achieve certified carbon neutrality for the Diocese and its institutions, in accord with GC80 A087, Net Carbon Neutrality by 2030; and be it further

Resolved, that Diocesan Council prepare a plan to measurably reduce the carbon footprint of travel by diocesan officials, employees, and deputies; and be it further

Resolved, that the Diocese and congregations develop plans for the cost-effect installation of solar panels on appropriate properties within the Diocese; and be it further

Resolved, that Diocesan Council develop plans for the creation of a climate finance program to empower individuals, households, and congregations throughout the Diocese to implement common-sense measures to address climate change; and be it further

Resolved, that Diocesan Council will work to educate, heighten awareness and provide resources addressing climate change and the care of God's creation to all children, youth and adults in the life of the Diocese; and be it further

Resolved, that Diocesan Council will work with the Bishop's Commission on Climate Change to advocate for local, statewide, and federal regulation to address the systemic causes of climate change; and be it further

Resolved, that the Bishop's Commission on Climate Change be asked to host a climate change town hall webinar in 2023, to educate and encourage further climate action within congregations and the Diocese; and be it further

Resolved, that the Bishop's Commission on Climate Change be asked to establish working relationships with similar groups active in other California dioceses; and be it further

Resolved, that Diocesan Council will prepare a written and verbal report to the One Hundred Twenty-eighth Annual Meeting of the Diocese which will outline potential budget and staffing implications as well as a plan for implementing these practical measures in the life of the Diocese; and be it further

Resolved, that each congregation be asked to name a liaison to the Bishop's Commission on Climate Change, for the purpose of receiving information and reporting on the implementation of efforts to address climate change.

Explanation:

Across the Church, dioceses and diocesan institutions have begun to implement practical measures to address climate change (See: Resolution #3, 2021, Diocese of California, Carbon Sequestration – Creates an Internal Carbon Offset Program; Resolution 20-03, Diocese of San Diego, Advancing Creation Care through Clean Renewable Energy for EDSD Churches). The General Convention has also made moves toward practical actions for the Church in its quotidian operation (See: 2018-A014, Create a Pilot Carbon Offset Program; 2018-D053, Stewardship of Creation with Church-Owned Land). Adopting this resolution will direct the Diocese to study and responsibly implement practices that will cut down on the Diocese's contributions to climate change.

Report of the Joint Budget Committee on the 2023 MSF Budget

Joint Budget Committee Process

Appointed by Bishop Taylor, the Joint Budget Committee (JBC) comprises members of Diocesan Council and directors of the Corporation of the Diocese (COTD). It is convened by Canon Andy Tomat, the Diocesan treasurer, and advised and assisted by the chief financial officer, the Rev. Susan Stanton. The committee and its subcommittees met frequently from July through October to review proposed expenses and income. The JBC proposed a balanced budget of \$11,628,673 on a consolidated basis, with \$4,577,500 coming from the Mission Share Fund (MSF) portion, which convention is asked to approve. The COTD and the Bishop as Corporation Sole ("Corp Sole") have already approved their portions.

Consolidated Budget Presentation

This consolidated budget is balanced without depleting either unrestricted cash and investments or principal from the endowment and restricted funds in Corp Sole or the COTD.

At the recommendation of Diocesan Council, convention delegates are being asked to review prayerfully the MSF portion (highlighted in the pink column). The allocation of expenses to MSF follows Canon 19.06 in providing funds for "the equitable share of the general church program budget" as well as "the funding of deanery programs and to the ministry of area pastors," specifically mission vicars.

In addition to the budget summary presented here, line-item detail is available online at <u>www.diocesela.org/convention/budget</u>. Estimated year-end 2022 results are also shown online for each income and expense line item.

Income Assumptions

Mission Share Fund income comes primarily from payments from parishes and mission congregations. Based on feedback from Diocesan Council, the JBC set the expected levels of MSF income from parishes and mission congregations in 2023 at \$4,550,000. This increase considers diocesan-wide average increases in pledge and plate giving, expected collection of significant past due payments of previous MSF commitments, continued year-over-year increases in percentage commitments to MSF, and word that several larger parishes plan to move to the 12% giving level in 2023.

The shortfall in the canonically required 12% of parish giving to the Mission Share Fund in 2022 has dramatically impacted the diocese's ability to fund critical administrative functions, provide financial assistance to support mission congregations, and grow new mission and ministry. In September 2022, Bishop Taylor and Canon Tomat told Diocesan Council that, according to the JBC's recommendation, a policy of mandatory assessments would take effect beginning January 1, 2024, after a year's study and discernment about best practices, including an appeals process.

The Corp Sole portion is primarily income, not principal, from restricted funds. The COTD-controlled portion includes a combination of grant income (primarily for IRIS and Seeds of Hope) and a small amount of income from the new diocesan endowment funds to grow ministries and support the

Neighborhood Youth Association. Grant-funded programs also now include 10% in their grant applications for administrative support provided by the Diocese.

Expense Assumptions

On the expense side, through prayerful discernment and debate, the JBC achieved a total reduction of \$900,000 from initial requests. The primary reductions were achieved through significant reform of our benefit programs – among the most generous in The Episcopal Church – while continuing to meet our commitments to ensuring health care for all and parity between clergy and lay employees. We are still able to provide excellent benefits to our employees, comparable to local institutions such as UCLA. These decisions were not easy, and many of the initial suggested reductions were altered or deferred in the JBC's subsequent discussions with the Bishop, Canon to the Ordinary, and staff.

Final Prayers of Thanks

The Committee wishes to offer prayers of thanks to the Bishop for moving the Diocese towards a new model of transparency and governance and especially for the invaluable assistance of our Finance Department under the leadership of the Rev. Susan Stanton.

Acknowledgement and Thanksgiving for the Land

Creator, you made all people of every land. We give thanks to those who first occupied this land we identify as the Episcopal Diocese of Los Angeles.

We respectfully acknowledge and recognize that the city of Riverside is located on the unceded land of the Cahuilla, Gabrieleno, Serrano, Luise'o, Chemehuevi, and Mohave tribes. Eighteen treaties were made between 1851 and 1852 with California tribes that the U.S. Senate decided not to ratify in secret session at the request of the state of California. If the treaties had been honored, tribes would possess more than 7.5 million acres of land in the state, but today California tribes own about 7% of their unratified treaty territory. This land holds great historical, spiritual, and personal significance for the original caregivers and for their relatives today.

We are honored to add our blessings today to the land that was and is held sacred by the Indigenous peoples who called it home. We pray that future residents will be taught to treat the land with respect and to give thanks to the Creator who made it. **Amen.**
